**The agenda for the meeting shall, inter alia, be as per Rule 10 of the Association, as under:**

1. To confirm the minutes of the last Annual General Meeting and Executive Board Meetings held during the year 2025-2026.
2. To receive and adopt the Annual Report for 2024–25 and the audited statement of accounts for the year 2024–25 as presented by the Committee.
3. To consider any recommendations of the Executive Committee and/or any motions and notices received from affiliated member associations.
4. To discuss the future development plan for the promotion of table tennis in Haryana.
5. To elect an auditor for the year 2026–27 and fix remuneration.
6. To fix dates of All Rankings and State Championships for the year 2026–27.

(Executive Committee shall consist of not more than 15 members of whom at least 2 shall be Sports Persons and at least 4 members shall be Women).

The Election of Office Bearers will be conducted in accordance with the provisions of the Sports Governance Act, 2025, dated 18th August, 2025.

Nomination Forms of candidates will have to be proposed and seconded by voting members of the General Body.

Mrs Neha Gakhar, Advocate, will be the Returning Officer of the Election.
